PVPSA Services Still Operating During COVID-19

PVPSA is enhancing safety measures in our programs, with the goal of reducing person-to-person contact. We know that there are many children and youth demonstrating anxiety or who need to seek counseling services. We are able to provide counseling services through voice and video conferencing and, if absolutely necessary, in person. If your child has Medi-Cal, you can continue to access our counseling services. Some services for children lacking Medi-Cal may also be available and we encourage you to contact our agency for any socio-emotional supports your child may need. We recognize these are challenging times and we are here to support your child and your family.



Our Mayou Family Center located at 411 East Lake, will remain open for crisis and walk-in situations only. If you have an emergency situation and need to access our services in person, we will be providing thorough health screening before entering the building. Please contact (831) 728-6445 if you need to access this option.

The following agency-wide changes have been implemented:

- All counseling services for existing and new clients will continue to be available via telephone or telehealth. In person appointments are scheduled only on a case by case basis and reserved for children and their families with no other option for care.
- All restorative justice services for youth currently receiving PVPSA support will continue to be made available using telephone and telehealth formats. All house visits have been canceled.
- The administrative office at 335 East Lake will be open on Fridays from 8:30am 4:30pm.
- The Counseling Center is open Monday Friday from 8:00am 5:00pm, for previously scheduled in person appointments. Necessary evening appointments are handled on a case by case basis.
- All children and youth receiving counseling supports at school continue to have the opportunity to do so.
 Our team has been calling all families to discuss options for continued care.

The PVPSA Executive Team is communicating daily to evaluate and update internal protocols based on medical and government guidelines. We also recognize that families need information about several resources and supports. We are working to develop a directory of services available as a result of this pandemic. Please look to our website and social media posts for this information. Please know that we will continue to update you about any changes to our services.
